1 Parties

This Agreement is entered into on the date of 15/12/2023, by and between:

- <u>DocDuck</u>, now referred to as the "Buyer",
- <u>BookCook</u>, now referred to as the "Seller".

2 Scope of Work

The Seller agrees to provide the Buyer with the following media as described in APPENDIX A attached.

3 Payment

In consideration for the Media, the Buyer agrees to pay the Seller the total amount of $\pm 1,000$, according to the payment schedule outlined in APPENDIX B attached.

4 Delivery

The Seller agrees to deliver this Media to the Buyer by the date of 15/03/24. The delivery method and specifications are outlined in APPENDIX A.

4.1 Non-Delivery

In the event that the Seller fails to deliver the Media by the agreed delivery date, the Buyer shall provide a notice to the Seller indicating non delivery.

4.2 Non-Delivery Remedies

Upon receipt of the notice of non-delivery, the Seller will have <u>7</u> days to amend the non-delivery and deliver the Media to the Buyer. If the Seller fails to cure the non-delivery within the specified period, the Buyer may choose one or both remedies:

- 1. Terminate the Agreement and receive a full refund of all payments made.
- 2. Extend the delivery date, with appropriate adjustments to the payment schedule

5 Non-Conformance with Specifications

5.1 Specifications and Quality

The Seller agrees to provide media that meet the specifications outlined in APPENDIX A. The Seller further agrees that the provided graphics and images will meet standards for quality.

5.2 Inspection and Acceptance

Upon receipt of the media, the Buyer shall have a period of $\underline{3 \text{ days}}$ for inspection to ensure conformity with specifications. If the media does not meet the specifications or the agreed-upon quality standards, the Buyer will provide notice to the Seller specifying the non-conformance.

5.3 Seller's Obligation on Non-Conformance

Upon notice of non-conformance, the Seller must investigate and amend the non-conformance. The Seller will bear all costs associated with correcting the non-conformance.

5.4 Non-Conformance Remedies

If the Seller fails to cure the non-conformance within the time frame of 7 days , the Buyer may:

- 1. Reject the non-conforming graphics and images and request a refund.
- 2. Request replacement graphics and images that meet the agreed-upon specifications.
- 3. Allow the Seller a reasonable opportunity to correct the non-conformance.

6 Intellectual Property

The Seller represents and warrants that they have the right to sell the Media and that the Media does not infringe on any third-party intellectual property rights.

7 Revision

The Buyer is entitled to <u>3</u> rounds of revisions, as outlined in APPENDIX A. Additional revisions may incur additional charges.

8 Termination of Contract

Either party may terminate this Agreement with written notice if the other party breaches any material term of this Agreement. In the event of termination, the Buyer shall pay for any services or deliverables provided up to the termination date.

9 Signature and Date

All prior agreements, whether verbal or written, have been replaced by this Agreement, which represents a complete understanding between the parties.

A Description of Media and Delivery Specifications

The Seller is asked to produce a Java Library (the "Library"). The Software is expected to be delivered in the form of source code. DocDuck requires BookCook to develop a Library to display videos in accordance with the technical brief for the Software Engineering Project 2023/2024. The Library must contain:

- VLCJ library should be used
- JavaFX library should be used for displaying the audio player
- Audio can be played and paused
- Audio player should scale to custom sizes
- Audio should be able to play files at a minimum bit-rate of 128kbps
- Audio should be able to loop
- The library should be able to import audio from a URL
- The Library should be able to display the audio player on the screen at a position given to it
- The audio player should come with a volume controller
- Code should have a clear and concise naming scheme
- All methods and classes should be well documented making use of the JavaDoc commenting style.

B Payment Schedule

The total amount to be paid by the buyer for this contract amounts to $\underline{\pounds 1,000}$ Upon signing of this contract, the Buyer must pay $\underline{\pounds 250}$ within <u>3 days</u>. A further payment of $\underline{\pounds 500}$ is to be payed within <u>3 days</u> upon delivery of the software as defined in Section 4. the Buyer will pay the final amount of $\underline{\pounds 250}$ when the software is determined to satisfy the requirements of APPENDIX A, as defined in Section 5.
